THE REGULAR BAKER CITY COUNCIL MEETING WAS HELD WEDNESDAY, APRIL 5, 2023 AT 7:00 P.M. IN THE FALLON COUNTY COURTROOM.

MEMBERS PRESENT: Mayor; Steve Zachmann, Councilors; Pat Ehret, Brittany Hoversland, Tracey Goerndt, Mike Loutzenhiser, City Attorney; Rich Batterman, Police Chief; Justin LaCroix, Director of Public Works; Rod Morris, Fire Chief; Tom Bruha and Clerk Treasurer; Kevin Dukart.

GUESTS: Jason Griffith, Lacey Berg, Vaughn Zenko and C. B. Heiser.

The Pledge of Allegiance was recited.

PUBLIC COMMENT: None

Mayor Zachmann requested to add to the agenda; Baker Clean Up Days. No objection.

Motion by Pat Ehret, second by Tracey Goerndt to approve the Consent Agenda Minutes of March 22, 2023 and Claims for March 2023. Motion Carried. All Aye.

OLD BUSINESS:

Reviewed the lone bid for Park Maintenance for the upcoming year from Tod and Lisa Passmore. The approximate cost will be about \$71,000 for the entire year. Lisa had indicated they would provide a Certificate of Insurance to comply with the limits required in the bid.

Motion by Tracey Goerndt, second by Brittany Hoversland to approve the Park Maintenance bid as submitted, contingent on providing of a proper Certificate of Insurance. Motion Carried. All Aye.

Attorney Batterman agreed to draft a contract for these services.

Vaughn Zenko and Lacey Berg were present to discuss the Food Forrest Grant Project. It was clarified that the city would donate the use of land for the project near the softball fields south of Baker Lake.

Attorney Batterman will draft an Interlocal Agreement between the city and SMART for the Food Forrest Project.

Clerk Dukart discussed a request for a donation for the Firework's Fund, previously the city donated \$500.00. Motion by Tracey Goerndt, second by Mike Loutzenhiser to defer this matter until the next meeting to gather more information on the status of funds available for the fireworks display. Motion Carried. All Aye.

Members of Baker High School Senior Class requested to have the city place banners on the State Highway.

Brittany noted that this was originally done because of COVID. Mayor Zachmann stated the cost for the city to place and remove the banners is approximately \$1,200 in labor and equipment.

Motion by Brittany Hoversland, second by Pat Ehret that for this year, we request the Senior Class to contribute up to \$1,200 for this service. Motion Carried. All Aye.

PUBLIC WORKS INPUT:

Rost Rod reported that they have been working on potholes on mainly 3rd, 4th and 5th Streets West. These are only temporary repairs as the ground is not dry yet.

The crew repaired a water leak last week Friday until 11:00 p.m. on 1st Street West. The clamp was corroded at a service line. Rod asked if the city would consider paying for a meal for the crew in situations like this in the future?

Rod stated that he would like to prepare an ad to hire a temporary 32 hr. per week opening for this upcoming summer for consideration at the next meeting. The main duties will be street sweeping, mowing and weed spraying.

CLERK TREASURER INPUT:

The Employee Benefits Health Insurance renewal was available. The increase in the medical rate was 9%, which is the largest increase for quite some time.

MAYOR INPUT:

Steve noted that drivers have run over some of the cones that have been placed near the potholes and cautioned drivers to be aware of that.

Thank you to the city crew for their work on the water leak.

Steve reported that My City Pocket is inactive currently and he has been using Facebook for public notifications.

CITY ATTORNEY INPUT:

Rich reported that he's completed 3 trials in the past 3 weeks, so he is now catching up on other office work.

COUNCIL INPUT: Pat Ehret – Is glad to be back.
