The City of Baker should be able to use the same consultant based on the Interlocal Agreement we have with Fallon County for these services.

Tom reported that they are currently having the inspections completed on the pumper trucks which is done annually.

### MAYOR'S INPUT:

Steve reported that the My City Pocket notification app is no longer in service for citizen notification. The Facebook page, radio and newspaper, if time allows, will be used for notifications. Steve stated that the local baseball team is playing on Coldwell Field this evening but the season is almost complete.

Steve expressed his appreciation to the group who attended the meeting to discuss the issue of allowing chickens in the city. He encourages citizens to contact the city officials with matters they believe are important to the community.

# CITY ATTORNEY INPUT:

Rich reported that he has been involved in several criminal prosecutions and appreciates the thorough work of the Police Department. He recently attended a seminar in Miles City sponsored by the State Bar Association. The Department of Justice had a representative there to discuss the issue of vehicular homicide prosecutions resulting from those who drive impaired. Rich stated that upon having a Planner in place discussions should begin on the matter of combining zoning and planning boards if allowed by statues.
